In view of 2021-22 batch is phasing out and to enable the students with continuity of studies, the following is notified .

"Considering that the 2021-22 batch is phasing out and as a one-time measure, students of affiliated and autonomous colleges are permitted to seek admission to the 7<sup>th</sup> semester of B.E., B. Tech., or B. Plan. programs and the 9<sup>th</sup> semester for B.Arch. programs, even if they have backlogs from the 1<sup>st</sup> or 2<sup>nd</sup> semesters. This clause is also applicable to students of autonomous colleges".
