I am directed to state that the Executive Committee of the Council of Architecture (COA) at its 145<sup>th</sup> Meeting held from May 27 & 28, 2015, considered the assessment report of the Inspection Committee that visited your Institution on 23rd & 24th May 2015, duly scrutinised by the Scrutiny Committee of Experts (copy enclosed), together with the information provided by institution, for extension of approval of **5 year full-time Bachelor of Architecture (B.Arch.) degree course**.

The Executive Committee has decided to grant extension of approval to **5 year full-time Bachelor of Architecture (B.Arch.) degree course** as under:

DETAILS OF THE COURSE	INTAKE	PERIOD OF APPROVAL
5-year Full-Time Bachelor of Architecture	80	2015-2016

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as **Annexure-A**.

The numerical scores assigned in the assessment report of the institution are only for the purpose of evaluation of Minimum Standards prescribed by the Council. These are not a reflection of the institutional merit and should not be used for any promotional purposes or in any other manner in the public domain. Any violation in this regard shall attract disciplinary action against the institution. Further, any error/rectification in calculation of marks in the assessment report has also been taken into account by the Executive Committee.

The final observations of the Executive Committee are mentioned below for necessary information/compliance:

Extension of Approval

- Vacant Faculty positions to be filled up. At least one Regular Professor should be appointed.

Additional Intake

- Inadequate existing Teaching Faculty as well as identified Faculty and Physical Infrastructure is inadequate.

Further, the Executive Committee also rejected the application of your institution for additional intake of 40 in the existing B.Arch. degree course due to lack of faculty and physical & academic infrastructure & facilities for the additional intake.

**NORMS OF COUNCIL OF ARCHITECTURE FOR IMPARTING B.ARCH.COURSE**

1. **5 year full-time Bachelor of Architecture (B.Arch.)** degree course is to be imparted by an architectural institution in an independent building and separate land having its own infrastructure and budgetary provisions.

Every architectural institution must acquire a built-up space of **3000 sq.mtr.** (i.e. 15 sq.mtr. per student) of its own, available for the course for an annual intake 40 students within the next three years of its establishment. Further, an institution applying for additional intake shall be required to create adequate infrastructural facilities in proportion to the additional intake sought, as and when sanctioned by the Council (as per detailing provided in the Evaluation System for undertaking Inspections provided at the website of the Council). The Institution shall ensure that its building and premises and other spaces must be barrier free (i.e. disabled friendly).

2. The Institution must have valid affiliation with a University established by an Act of the Central or State Legislature or conferred authority by Law to award Degree Course in Architecture. No admission shall be made by the Institution without valid affiliation with a University.
3. The Institution having intake of more than 40 students shall be required to conduct classes concurrently in separate batches of 40 students each.
4. The Institution shall recruit and always maintain the Architecture Teaching Faculty as per the Minimum Qualifications, Experience and Structure for Teaching Posts in a Degree Level Architectural institution, prescribed in **Appendix-B1** of the **Minimum Standards Minimum Standards of Architectural Education, 2008** of the Council. The Standards are available at the website of the Council.
5. For an annual intake of 40, the Institution shall have minimum staff structure of full time faculty, in addition to the Principal/ Director, as following :

Professors – 2, Asst. Professors – 4, Lecturers – 8

Of these full time teachers 50% may be on permanent posts and rest on tenure basis with tenures of 3, 5, 7 or 10 years depending upon their caliber as teacher.

For intake more than 40, proportionate increase in faculty shall be as per detailing provided in the Evaluation System for undertaking Inspections provided at the website of the Council.

6. The eligibility criteria for admission to 1<sup>st</sup> of 5-year B.Arch. degree course is as under :  
*"No candidate, with less than 50% marks in aggregate, shall be admitted to the architecture course unless he/she has passed an examination at the end of the new 10+2 scheme of Senior School Certificate Examination or equivalent with Mathematics as subjects of examination at the 10+2 level."*
7. The institution shall admit only such students who fulfill the eligibility criteria prescribed by the Council and have passed an Aptitude Test in Architecture conducted by a competent authority. No direct lateral admission of any student into any year/stage of the B.Arch. course is allowed as per Council Norms.
8. All admissions made by the institution under various quotas/categories must be strictly within the intake sanctioned by the Council for an academic session. The students belonging to NRI, Foreign National, PIO etc. are also required to be admitted within the sanctioned intake, subject to passing an aptitude test. Further, reservation of students/relaxation of marks in qualifying examination for admission to the B.Arch. course shall be as per the policy of respective Central/State Government.
9. All admissions must be completed by the institution before 1<sup>st</sup> **September** i.e. the date of commencement of B.Arch. classes prescribed by the Council.

10. The Institution shall follow the Duration and Stages of the Course, Admission to the Architecture Course, Courses and periods of Studies, Standards of staff, equipment, accommodation, training and other facilities for architectural education as per the Minimum Standards of Architectural Education prescribed by the Council from time to time,
11. The institution must acquire minimum 300 books on subjects of Architecture in its library for an intake of 40 (including minimum 100 titles) before the commencement of the course. Subsequently, 150 books (including minimum 50 titles) are to be added for annually per intake of 40. Library of established schools, having more than 5000 books, should acquire minimum 50 titles on subjects of Architecture per intake of 40 every year.
12. The Institution shall be required to have a nominee of the Council in the Interview Board or Selection Committee etc. set up for recruitment(s)/promotion(s) in respect of Architecture Teaching Faculty positions. The said Council nominee will act as a full-fledged Member of the Interview Board/Selection Committee and help in scrutinizing the qualification, experience and other relevant details of the applicants for selection of suitable candidates. Recruitments or Promotions made to architecture faculty positions in the Institution without COA nominee shall not be deemed valid by the Council.
13. The Head as well as other Architecture teaching faculty of the institution must have valid registration as an Architect from the Council of Architecture under the Architects Act, 1972.
14. The Institution shall follow the "**Council of Architecture – Minimum Standards of Architectural Education, 2008**" which have been prescribed pursuant to Section 21 of the Architects Act, 1972 supplementing the Council of Architecture (Minimum Standards of Architectural Education) Regulations, 1983, for imparting the above said B.Arch. degree course.
15. The Institution shall initiate necessary steps to curb ragging in its premises and take appropriate action as prescribed by competent authority in case of any such incident.
16. The Institution shall ensure that women (staff, faculty or student) are protected against sexual harassment at the institution and initiate necessary steps as prescribed by competent authority.
17. All the circulars/ notices including the intake sanctioned by the Council to Institution(s) shall be displayed on the Notice Board of the Institution for information of the students and faculty members.
18. Any Institution which fails to maintain the Minimum Standards of Architectural Education shall be liable to attract sanctions as provided under the said Standards and may also include recommendation for withdrawal of recognition the qualification imparted at the Institution.
19. The affiliating University of the institution shall create an independent Faculty of Architecture and independent Board of Studies in Architecture for proper growth and development of course in Architecture and prepare Syllabus, Course Curriculum, Scheme of Examination in accordance with the Minimum Standards of Architectural Education as prescribed by Council. At least 1/3 of its members must be from practice.
20. In due course, the affiliating University should also create a Board of Studies in Architecture, Interior Design, Building Construction Technology etc. under the Faculty of Architecture to deal with issues connected with these disciplines at UG and PG level, having at least 1/3 of its members from practice.
21. The institution must constitute an independent Governing Council for a School of Architecture, having Architect members in majority. The institution shall also create Course Committees for continuous development of educational programme in Architecture. At least 1/3 of its member must be from practice.



## NORMS OF COUNCIL OF ARCHITECTURE FOR IMPARTING B.ARCH.COURSE

1. **5 year full-time Bachelor of Architecture (B.Arch.)** degree course is to be imparted by an architectural institution in an independent building and land having its own infrastructure and budgetary provisions, as provided under Minimum Standards of Architectural Education, 2015 prescribed by the Council.

Institution must own a minimum 8000 Sq. M. or Independent or undivided and contiguous share of land adequate enough to provide for built floor space of 2,000 Sq.M. for Intake of 40; 3,000 Sq.M. for intake of 80; and 4,000 Sq.M. for intake of 120 in B.Arch. course; provided further that the built space should be contiguous.

Further, the Institution should also have sufficient space for sports, co-curricular activities and hostel, canteen and other facilities. The land where the building of the institution is located/built must be institutional land and must be owned or availed on long lease (more than 33 years with provision of renewal) by the trust / society / company. An institution applying for additional intake shall be required to create adequate infrastructural facilities in proportion to the additional intake sought, as and when sanctioned by the Council (as per detailing provided in the Minimum Standards). The Institution shall ensure that its building and premises and other spaces must be barrier free (i.e. disabled friendly).

2. The Institution must have valid affiliation with a University established by an Act of the Central or State Legislature or conferred authority by Law to award Degree Course in Architecture. No admission shall be made by the Institution without valid affiliation with a University.
3. The Institution having intake of more than 40 students shall be required to conduct classes concurrently in separate batches of 40 students each.
4. The Institution shall recruit and always maintain the Architecture Teaching Faculty as per the Minimum Qualifications, Experience and Structure for Teaching Posts in a Degree Level Architectural institution, prescribed in **Appendix-B1** of the **Minimum Standards of Architectural Education, 2015** of the Council. The Standards are available at the website of the Council.
5. For an annual intake of 40, the Institution shall have minimum staff structure of full time faculty, in addition to the Principal/ Director/Head of the Institution, as follows :

Professors – 1, Associate Professors – 4, Assistant Professors – 7

Minimum 50% Teaching Faculty must be recruited on cadre wise Regular basis. Balance teaching faculty up to 50% can be on cadre wise Tenure basis.

For intake more than 40, proportionate increase in faculty shall be as per detailing provided in the Minimum Standards of 2015.

6. The eligibility criteria for admission to 1<sup>st</sup> of 5-year B.Arch. degree course for 2016 2017 is as under :  

*"No candidate, other than a candidate possessing 50% marks in aggregate and with Mathematics as subject of examination at the end of 10+2 scheme of Senior School of Certificate Examination or equivalent examination, shall be admitted to the architecture course;"*

Please refer to Minimum Standards of 2015 for more details.
7. The institution shall admit only such students who fulfill the eligibility criteria prescribed by the Council and have passed an Aptitude Test in Architecture conducted by a competent authority. 

**NORMS OF COUNCIL OF ARCHITECTURE FOR IMPARTING B.ARCH.COURSE**

1. **5 year full-time Bachelor of Architecture (B.Arch.)** degree course is to be imparted by an architectural institution in an independent building and land having its own infrastructure and budgetary provisions, as provided under Minimum Standards of Architectural Education, 2017 prescribed by the Council.


Institution must own a minimum 8000 Sq. M. or Independent or undivided and contiguous share of land adequate enough to provide for built floor space of 2,000 Sq.M. for Intake of 40; 3,000 Sq.M. for intake of 80; and 4,000 Sq.M. for intake of 120 in B.Arch. course; provided further that the built space should be contiguous.

Further, the Institution should also have sufficient space for sports, co-curricular activities and hostel, canteen and other facilities. The land where the building of the institution is located/built must be institutional land and must be owned by the trust / society. An institution applying for additional intake shall be required to create adequate infrastructural facilities in proportion to the additional intake sought, as and when sanctioned by the Council (as per detailing provided in the Minimum Standards). The Institution shall ensure that its building and premises and other spaces must be barrier free (i.e. disabled friendly).

2. The Institution must have valid affiliation with a University established by an Act of the Central or State Legislature or conferred authority by Law to award Degree Course in Architecture. No admission shall be made by the Institution without valid affiliation with a University. NOC/affiliation letter from the university must be obtained and submitted to the Council at the earliest.
3. The Institution having intake of more than 40 students shall be required to conduct classes concurrently in separate batches of 40 students each.
4. The Institution shall recruit and always maintain the Architecture Teaching Faculty as per the Minimum Qualifications, Experience and Structure for Teaching Posts in a Degree Level Architectural institution, prescribed in the Minimum Standards of Architectural Education, 2017 of the Council. The strength of full time-faculty based on sanctioned intake is depicted in the table below.
5. The eligibility criteria for admission to 1<sup>st</sup> of 5-year B.Arch. degree course for 2019-2020 is as under:  
***"No candidate shall be admitted to architecture course unless she/ he has passed an examination at the end of the 10+2 scheme of examination with at least 50% aggregate marks in Physics, Chemistry & Mathematics and also at least 50% marks in aggregate of the 10+2 level examination or passed 10+3 Diploma Examination with Mathematics as compulsory subject with at least 50% marks in aggregate."***
6. The institution shall admit only such students who fulfill the eligibility criteria prescribed by the Council and have passed an Aptitude Test in Architecture conducted by a competent authority. No direct lateral admission of any student into any year/stage of the B.Arch. course is allowed as per Council Norms.
7. All admissions made by the institution under various quotas/categories must be strictly within the intake sanctioned by the Council for an academic session. The students belonging to NRI, Foreign National, PIO etc. are also required to be admitted within the sanctioned intake, subject to passing an aptitude test. Further, reservation of students/relaxation of marks in qualifying examination for admission to the B.Arch. course for reserved categories shall be as per the policy of the Central/ respective State Government.
8. All admissions must be completed by the institution before **1<sup>st</sup> September** i.e. the date of commencement of B.Arch. classes prescribed by the Council.
9. The Institution shall follow the Duration and Stages of the Course, Admission to the Architecture Course, Courses and periods of Studies, Standards of staff, equipment, accommodation, training and other facilities for architectural education as per the Minimum Standards of Architectural Education prescribed by the Council from time to time.
10. The institution must acquire minimum 300 books on subjects of Architecture in its library for an intake of 40 (including minimum 100 titles) before the commencement of the course. Please add 150 books (including minimum 50 titles) for every additional intake of 40. From 2<sup>nd</sup> year onwards, minimum 120

books (including minimum 40 titles) for every year per intake of 40. Library of old schools, having more than 5000 books, should acquire minimum 30 titles on subjects of Architecture per intake of 40 every year.

11. The Institution shall be required to have a nominee of the Council in the Interview Board or Selection Committee etc. set up for recruitment(s)/promotion(s) in respect of Architecture Teaching Faculty positions. The said Council nominee will act as a full-fledged Member of the Interview Board/Selection Committee and help in scrutinizing the qualification, experience and other relevant details of the applicants for selection of suitable candidates. Recruitments or Promotions made to architecture faculty positions in the Institution without COA nominee shall not be deemed valid by the Council.
12. The Head as well as other core Architecture teaching faculty of the institution must have valid registration as an Architect from the Council of Architecture under the Architects Act, 1972.
13. The Institution shall follow the Minimum Standards of Architectural Education, 2017, prescribed by the Council pursuant to Section 21 of the Architects Act, 1972.
14. The Institution shall initiate necessary steps to curb ragging in its premises and take appropriate action as prescribed by competent authority in case of any such incident.
15. The Institution shall ensure that women (staff, faculty or student) are protected against sexual harassment at the institution and initiate necessary steps as prescribed by competent authority.
16. All the circulars/ notices including the intake sanctioned by the Council to Institution(s) shall be displayed on the Notice Board of the Institution for information of the students and faculty members. The same shall be available on the website of the institution along with details regarding physical & academic infrastructure and faculty.
17. Any Institution which fails to maintain the Minimum Standards of Architectural Education shall be liable to attract sanctions which may include recommendation for withdrawal of recognition the qualification imparted at the Institution.
18. The affiliating University of the institution should preferably create an independent Faculty of Architecture and independent Board of Studies in Architecture for proper growth and development of course in Architecture and prepare Syllabus, Course Curriculum, Scheme of Examination in accordance with the Minimum Standards of Architectural Education as prescribed by Council. At least 1/3 of its members should be from the field of practice in Architecture.
19. In due course, the affiliating University should preferably also create a Board of Studies in Architecture, Interior Design, Building Construction Technology etc. under the Faculty of Architecture to deal with issues connected with these disciplines at UG and PG level, having at least 1/3 of its members from practice.
20. The institution should constitute an independent Governing Council for a School of Architecture, having Architect members in majority. The institution shall also create Course Committees for continuous development of educational programme in Architecture. At least 1/3 of its member must be from practice.





## NORMS OF COUNCIL OF ARCHITECTURE FOR IMPARTING M.ARCH. COURSE

1. **Space & Building:** The post graduate Department/Institution of Architecture should be located in a building / campus to have a floor area of about 250 sq.m. per post graduate course per shift. The physical space should include separate studios, computer centres, lecture rooms, faculty rooms and laboratories as required for the post graduate course. It is desirable to provide hostel accommodation and residential accommodation for staff and students in close proximity of the institutions. Hostel accommodation for students must be adequate for their academic needs. This factor should be borne in mind in the design of hostel rooms and studios. The Institution shall ensure that its building and premises and other spaces must be barrier free (i.e. disabled friendly).
2. **Eligibility for Admission:** Minimum of 50% marks in aggregate in a Bachelor of Architecture degree course or equivalent course.
3. **Teaching Faculty:** For an annual intake of 20 students, the institution offering post-graduate programmes shall have a minimum core faculty consisting of 1 Professor, 2 Associate Professors and 2 Assistant Professors for each post-graduate course. The minimum qualifications & experience of teaching posts shall be as per the Minimum Standards of Architectural Education, 2017, prescribed by the Council. The institution shall have a faculty student ratio of 1:5. The institution may have a maximum of 50% of its teachers as visiting faculty.
4. **Facilities & Staff:** The institute shall have adequate administrative staff and supporting technical staff for each of its laboratories, computer centres, library, which may be shared with U.G. courses in architecture of the institution. The institutions shall furnish the details of computers, equipment, accommodation, training and other facilities as detailed out in Appendix-C of Minimum Standards of Architectural Education Guidelines for Post-Graduate Programme 2006 prescribed by the Council for Post Graduate Architectural Programmes to the Council and the expert committee of the Council.
5. **Library:** The institution must acquire a minimum of 100 titles relevant to the proposed PG course and subsequently 50 titles be acquired annually and at least five journals be subscribed to (for each post-graduate course).
6. **Computer Studio:** The institution must create an exclusive P.G. Computer Lab with requisite software required for each course. Steps should be initiated to have a minimum of 10 computers per P.G. Course in the first year and additional 10 computers in the second year for each course. Computer centre shall have a server, networking and internet facilities.
7. **Workshop and Laboratory:** The institution must create well equipped related workshop facilities and the existing facilities be enhanced prior to commencement of academic session.
8. **Reservation & Non Availability of Sponsored Candidates:** The reservation in seats for the M.Arch. degree course may be followed as per the Central/State Government Policy. In case of non-availability of sponsored candidates, the same can be clubbed with General category.
9. The institution shall adhere to the Norms and Guidelines as prescribed by the Council in the Minimum Standards of Architectural Education Guidelines for Post-Graduate Programme 2006 and as prescribed from time to time.
